A RESOLUTION OF THE CITY OF PFLUGERVILLE, ADOPTING PARKS AND RECREATION COMMISSION STRATEGIC PLAN AND STRATEGIC CALENDAR TO GUIDE THE COMMISSION IN CARRYING OUT ITS DUTIES PURSUANT TO THE CITY CHARTER AND THE CITY ORDINANCE.

WHEREAS, the Parks & Recreation Commission was created by the City Charter; and

WHEREAS, the Parks & Recreation Commission's duties are identified in Section 8.10(c) of the City Charter and Section 95.23-95.28 of the Code of Ordinances; and

WHEREAS, the duties of the Parks & Recreation Commission are broad and general in nature and not prioritized within the Charter or Ordinance; and

WHEREAS, the City Council directed the City Manager to establish a focused priority plan for the Parks and Recreation Commission; and

WHEREAS, the citizens voted to approve a \$25 million parks and recreation bond; and

WHEREAS, prioritizing duties and adopting a strategic calendar to guide Commission activities will assist the Commission to operate efficiently and effectively and provide greater value to city park planning, management and maintenance;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE, TEXAS THAT:

- 1) the City hereby adopts the attached Parks & Recreation Commission Strategic Plan and Parks & Recreation Commission Strategic Calendar, and
- 2) the Parks & Recreation Commission shall use the Parks & Recreation Commission Strategic Plan & Parks & Recreation Commission Strategic Calendar to guide its duties as provided by the City Charter and Ordinance.

Parks and Recreation Commission Strategic Plan - 2015

Purpose

The Parks & Recreation Commission was created by the City Charter and its duties are identified in both the Charter and the City's Code of Ordinances. Due to the broadness of the duties and the fact that there is only so much time that can be dedicated to them, there is a need for further definition so that the Commission can operate more efficiently and effectively.
