Regular Meeting

1. Call to order

Mayor Victor Gonzales called the regular meeting to order at 7:01 p.m. Councilmembers Jeff Marsh, Omar Peña and Mike Heath were in attendance. Councilmembers Doug Weiss and Starlet Sattler were absent. Action on the Consent Agenda

Mayor Gonzales made a motion to approve the consent agenda. Mayor Pro Tem Peña seconded the motion. All voted in favor. The motion carried.

8. Discuss and consider action

 8A. 2017-5690 Discuss and consider approval of an agreement with Freese and Nichols, Inc. for phase 1 professional engineering services associated with pre-design development, TPDES permitting assistance and topographical surveying in the amount of \$375,806 for the expansion at the Central Wastewater Treatment Plant Upgrade Project.

Mr. Word provided information on the need to prepare for expansion of the current wastewater treatment plant. He stated that the City would need to complete the construction in the next few years. He stated that this is for the first phase of professional services for preliminary design development and permitting. He stated that staff recommends approval. Mr. Word explained that this expansion would take the wastewater treatment plant from 5.3 MGD to

9.0 MGD. He stated that this is anticipated to provide enough service for the city for another 15 years, when an additional plant will need to be established. He stated that the plant expansion cost is estimated at \$30 million. Mr. Word answered questions and discussion followed. Mayor Pro Tem Peña made a motion to approve item 8A as presented. Mayor Gonzales seconded the motion. All voted in favor. The motion carried.

8B. <u>2017-5691</u> Discuss and consider action to award a construction contract for the Sorento Wastewater Interceptor project to Whitestone Civil Construction, LLC, the lowest responsible bidder of nine (9) bids received on March 16, 2017, in the amount of \$1,880,999.50 and authorizing the City Manager to execute same.

Ms. Giannini provided information. She stated that staff recommends awarding the construction contract for the Sorento Wastewater Interceptor project to the lowest responsible bidder, Whitestone Civil Construction, LLC, in the amount of \$1,880,999.50 to include the base bid and bid alternate No. 1. Ms. Giannini answered questions of Council. Mr. Heath made a motion to approve item 8B as presented. Mr. Marsh seconded the motion. All voted in favor. The motion carried.

8C. <u>2017-5701</u> Discuss and consider action to award a construction contract for the Rowe Lane Safety Improvement Project to Cox Commercial Construction, LLC, the lowest responsible bidder of seven (7) bids received on March 9, 2017, in the amount of \$1,896,891.30 and authorizing the City Manager to execute same.

Ms. Giannini provided information. She stated that staff recommends awarding the construction contract for the Rowe Lane Safety Improvement project to the lowest responsible bidder, Cox Commercial Construction, LLC, in the amount of \$1,896,891.30. Ms. Giannini answered questions of the Council. Mayor Pro Tem Peña made a motion to approve item 8C as presented. Mr. Heath seconded the motion. All voted in favor. The motion carried.

Ms. Giannini provided information.She recommended approval. Mr. Marsh made a motion to approve item 8D as presented. Mayor Gonzales seconded the motion. All voted in favor. The motion carried.

Mr. Heath asked for a brief update on the progress of the Finance and Budget Committee. Mr. Marsh, Finance and Budget Committee member, was in agreement with the request for the item.
