Worksession

1. Call to order

Mayor Victor Gonzales called the worksession to order at 6:00 p.m.

Councilmembers Doug Weiss, Jeff Marsh, and Starlet Sattler were in attendance. Councilmember Mike Heath entered the worksession at 6:01 p.m.

2A. RES-0411 Discuss amending rules of order and procedure for City Council

meetings. (Requested by City Council)

Mr. Hyde reviewed and discussed the proposed changes to the document that were previously suggested. Mr. Hyde was to bring back to Council on May 9, 2017 for consideration.

2B. <u>2017-5644</u>

Discussion regarding Council reimbursement policy. (Requested by Councilmember Jeff Marsh)

Mr. Weiss stated that he would like to add the requirement for pre-approval for out of state travel. Discussion followed. Mr. Heath stated that he also thinks that reimbursement requests should be made within 30 days of travel and should include beginning and end destinations and a mileage log. Mr. Heath stated that he does not like the per dium and thinks that they need to provide receipts and that there be a maximum allowed per day. Discussion continued with Mr. Hyde.

2C. <u>2017-5783</u>

Discussion regarding Code of Ethics and policies related to Charter changes. (Requested by Councilmember Doug Weiss)

Mr. Hyde stated that he has provided an ordinance for their review to adopt a hearing process. He stated that they could discuss again at another worksession or consider for adoption at their discretion.

Discussion regarding cultural festival. (Requested by Councilmember

Mr. Weiss stated that he had placed on the agenda to discuss a possible fall festival. Ms. Sattler suggested that the event come from a working group of citizen volunteers. Discussion followed.
