Mr. Heath recommended doing a full city facility survey and to include the requested Recreation Center and Senior Center study with the rest for prioritization. Mr. Hemenes concluded that he would like to reallocate funds for the projects as discussed with the same funds already in place. He answered additional questions of the Council. Council asked regarding constructing a new facility instead of making improvements to the Bohls House. Mr. Hemenes said that it will take some investment to make it usable for any use. Council discussion followed.
