## RESOLUTION OF THE CITY OF PFLUGERVILLE, TEXAS PLEDGING SUPPORT FOR PFLUGERVILLE AREA PROJECTS FOR CAMPO FUNDING IN THE 2019-2022 PROJECT CALL

**WHEREAS**, the Austin-Round Rock Metropolitan Statistical Area (MSA) is among the most congested metropolitan areas in the country; and

**WHEREAS,** the Travis County population is projected to increase by 700,000 by 2040, and employment is projected to double; and

**WHEREAS**, collaboration and partnerships to construct necessary infrastructure to serve Pflugerville and northeast Travis County residents is imperative; and

**WHEREAS,** Travis County is responding to the 2019-2022 Project Call by the Capital Area Metropolitan Planning Organization (CAMPO) proposing projects located within Pflugerville's extraterritorial jurisdiction and City limits and is requesting Pflugerville's support and participation as a co-sponsor pledging financial participation for portions of projects within the Pflugerville City Limits in the event the projects are selected for funding; and

**WHEREAS,** the total project cost for the Jesse Bohls realignment, including right of way acquisition, design and construction is estimated to be \$9,700,000. If selected, the County and City of Pflugerville will enter into an interlocal agreement to coordinate the construction of the project. In accordance with CAMPO funding criteria, a 20% local match is required for selected projects, resulting in a County share of \$1,540,000 and a City share of \$400,000 should the Jesse Bohls realignment project be selected; and

**WHEREAS,** the total project cost for the E. Pecan / Cameron improvements, including right of way acquisition, design and construction is estimated to be \$10,510,000. The County is the sponsor of the project and the City of Pflugerville will be the cosponsor. If selected, the County and City of Pflugerville will enter into an interlocal agreement to coordinate the construction of the project. A 20% match is required for the project, resulting in a County share of \$1,723,640 and a City share of \$378,360; and

**WHEREAS**, the identified roadways proposed for improvement are consistent with the adopted transportation plans of the City of Pflugerville and Travis County.

# NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE, TEXAS:

That the City of Pflugerville supports that the following projects in accordance with the recitals above incorporated herein and is prepared to cosponsor and contribute funds required for components of the projects falling within the Pflugerville city limits should the project(s) qualify for funding:

- Jesse Bohls Road realignment with E. Pflugerville Parkway as a roadway safety project as depicted on Exhibit A with two-lanes and four-foot shoulders in the amount of \$400,000.
- E. Pecan Street / Cameron Road (E of SH 130) as a roadway safety project from Weiss Lane to the 1849 Park entrance as depicted in Exhibit B as a two-lane divided roadway separated by a two-way left turn lane in the amount of \$378,360.
- The City acknowledges that Travis County may seek Transportation Development Credits (TDC) in support of one or both of these projects, but Pflugerville does not intend to pursue them.
