AN ORDINANCE OF THE CITY OF PFLUGERVILLE, TEXAS, AMENDING THE CITY OF PFLUGERVILLE, TEXAS CODE OF ORDINANCES, BY AMENDING TITLE VII (TITLED TRAFFIC CODE), CHAPTER 72 (TITLED TRAFFIC SCHEDULES), SCHEDULE III (TITLED STOP SIGNS ON PUBLIC STREETS) BY ESTABLISHING ADDITIONAL STOP SIGNS LOCATIONS IN STONE HILL TOWN CENTER; PROVIDING FOR A VIOLATION OF CHAPTER 72 AS A CLASS C MISDEMEANOR AND A FINE IN AN AMOUNT NOT TO EXCEED \$200.00; PROVIDING THAT THIS ORDINANCE SHALL BE CUMULATIVE; REPEALING ALL ORDINANCES TO THE EXTENT THEY ARE IN CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the Texas Transportation Code authorizes the City of Pflugerville (City) to exercise jurisdiction over city streets, including the authority to place stop signs at intersections deemed appropriate by the City; and

WHEREAS the City has determined upon the basis of an engineering and traffic investigation that the intersections subject to this ordinance are unsafe under the conditions found to exist taking into consideration the width and condition of the pavement and other circumstances, as well as the usual traffic thereon; and

WHEREAS the City has determined that it would promote public safety to erect stop signs as set forth herein below, which shall be effective when appropriate signs giving notice thereof are erected at such intersections.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE, TEXAS:

Section 1. Findings. The foregoing recitals are hereby found to be true and correct and are hereby adopted by the City Council and made a part hereof for all purposes and findings of fact.

Section 2. Amendment to Municipal Code of Ordinances. The City of Pflugerville, Texas Code of Ordinances, Title VII (titled "*Traffic Code*"), Chapter 72 (titled "*Traffic Schedules*"), Schedule III (titled "*Stop Signs on Public Streets*") is hereby amended by adding language that is underlined (underlined) as follows:

SCHEDULE III. STOP SIGNS ON PUBLIC STREETS

The following stop signs are approved in addition to those previously approved by plat:

Stone Hill Town Center

- A stop sign at the Southwest corner of eastbound Stone Hill Drive facing west at its intersection with a private drive located approximately 400 feet east of Stone Hill Drive's intersection with Hilltop Commercial Drive.

- A stop sign at the Northeast corner of westbound Stone Hill Drive facing east at its intersection with a private drive located approximately 400 feet east of Stone Hill Drive's intersection with Hilltop Commercial Drive.
- A stop sign at the southwest corner of Town Center Drive facing west at its intersection with the private driveway 450 feet east of Hilltop Commercial Drive;
- A stop sign at the northeast corner of Town Center Drive facing east at its intersection with the private driveway 450 feet east of Hilltop Commercial Drive.
- A stop sign at the southeast corner of Limestone Commercial Drive facing south at its intersection with the private driveway 850 feet north of Town Center Drive;
- A stop sign at the northwest corner of Limestone Commercial Drive facing north at its intersection with the private driveway 850 feet north of Town Center Drive.
- A stop sign at the northwest corner of Limestone Commercial Drive facing north at its intersection with Town Center Drive.
- A stop sign at the southeast corner of Terrell Lane facing south at its intersection with Town Center Drive.
- A stop sign at the ~~northwest~~ northeast corner of Town Center Drive facing east at its intersection with Hilltop Commercial Drive.
- A stop sign at the ~~northeast~~ northwest corner of Limestone Commercial Drive facing north at its intersection with ~~Hilltop Commercial Drive~~ Limestone Commercial Drive.

Section 3. Severability. If any provision of this Ordinance is illegal, invalid, or unenforceable under present or future laws, the remainder of this Ordinance will not be affected and, in lieu of each illegal, invalid, or unenforceable provision, a provision as similar in terms to the illegal, invalid, or unenforceable provision as is possible and is legal, valid, and enforceable will be added to this Ordinance.

Section 4. Repealer. This ordinance shall be cumulative of all other ordinances of the City of Pflugerville, and this ordinance shall not operate to repeal or affect any other ordinances of the City of Pflugerville except insofar as the provisions thereof might be inconsistent or in conflict with the provisions of this ordinance, in which event such conflicting provisions, if any, are hereby repealed.

Section 5. Penalty. A violation of Schedule III of Chapter 72 of the Code of Ordinances after the Effective Date of this Ordinance shall be a Class C Misdemeanor with a fine of not less than \$1.00 or more than \$200.00 as provided in Chapter 542 of the Texas Transportation Code.

Section 6. Effective Date. This Ordinance will take effect upon its adoption by the City Council in accordance with Section 3.15(d) of the City Charter.
