**RESOLUTION OF THE CITY OF PFLUGERVILLE, TEXAS APPROVING THE  
COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) THIRD  
AMENDED ANNUAL ACTION PLAN FOR PROGRAM YEAR 2015.**

**WHEREAS**, the City of Pflugerville (City) is a Community Development Block Grant (CDBG) entitlement community as provided by the U.S. Department of Housing and Urban Development; and

**WHEREAS**, as an entitlement community, the City prepared and submitted a 2014-2019 Consolidated Plan that details the goals and objectives to be implemented to address community needs in the areas of affordable housing, homeless services, special needs population, and community and economic development needs; and

**WHEREAS**, the City amended the 2014-2019 Consolidated Plan in April of 2016 in order to address growing concerns from residents regarding the needs of senior citizens; and

**WHEREAS**, as an element of the Consolidated Plan, the City is required to prepare and submit an Annual Action Plan detailing the activities to be undertaken annually to address the goals and objectives outlined in the Consolidated Plan; and

**WHEREAS**, the City adopted a Citizen Participation Plan in accordance with the requirements established by the U.S. Department of Housing and Urban Development to encourage citizen participation with emphasis for participation by persons of low or moderate income and low and moderate income neighborhoods, slum or blighted areas, and areas in which grantees propose to use CDBG funds; and

**WHEREAS**, the City Council held public hearings on May 22, 2018 and June 12, 2018 to receive input from citizens and agencies having interest in the CDBG program; and

**WHEREAS**, the proposed amended plan was made available for comment online and at the Pflugerville Public Library and the Travis County Community Center from May 9, 2018 to June 12, 2018; and

**WHEREAS**, the City has met the requirements for citizen participation in preparation of this Plan and has allowed the opportunity for persons and agencies to identify needs and present concepts to help meet those needs through the CDBG program, as prescribed by the U.S. Department of Housing and Urban Development; and

**WHEREAS**, the City has amended the original 2015 Action Plan in order to reflect new projects that met the needs as established by the Amended Consolidated Plan; and

**WHEREAS**, the City received a CDBG award totaling \$247,840, to carry out activities that meet one of the three National Objectives, as described by the U.S. Department of Housing and Urban Development; and

**WHEREAS**, the CDBG Advisory Committee voted on June 4, 2018 to recommend approval of the 2015 Third Amended Annual Action Plan;

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE, TEXAS:**

That this Program Year 2015 Third Amended Annual Action Plan, attached as Exhibit A, is approved.

**BE IT FURTHER RESOLVED** that the Interim City Manager is authorized to submit the 2015 Amended Action Plan to the U.S. Department of Housing and Urban Development for their review and approval.
