2A. <u>2018-6778</u>

Discuss professional services opportunities for enhanced transportation funding opportunities, strategies and resources utilizing local and non-local funding sources.

Mr. Fletcher provided information on the opportunity to hire a consultant such as Mike Weaver with Prime Strategies to assist with transportation infrastructure planning and answered questions of the Council. Mr. Marsh and Mr. Heath spoke in support and discussion followed. Mr. Fletcher indicated that he would move forward with engaging the consultant.

2B. 2018-6781

Discussion regarding proposed amendments to the Unified Development Code (UDC) to include new and amended zoning districts, donation containers, airport overlay and mobile food vendors (food trucks).

Ms. Barron provided information on proposed amendments to create a new base zoning district for Public Facilities and Open Space and to create an

airport hazard overlay district. She answered questions of the Council with input from Mr. Fletcher. Ms. Barron provided information regarding adding provisions for donation containers as an accessory use to non-residential uses. She answered questions of the Council. There was Council discussion with input from Ms. Barron, Mr. Fletcher and Mr. Zech. Mr. Zech indicated that legal would need to review the proposed ordinance and would make recommendations prior to Council consideration. There was continued discussion. Ms. Barron stated that they would bring back the donation container ordinance again for discussion following legal review. Ms. Barron provided information on the possibility to add provisions for food trucks and answered questions of the Council. She asked Council for guidance on the provisions they would like to see. There was continued discussion. The Council recommended reducing the fees for the food trucks for three months, holding some food truck public events and having reciprocal agreements with other agencies for food permits.
