#### 1. Call to order

Mayor Victor Gonzales called the special meeting to order 5:02 p.m. Councilmembers Doug Weiss, Jeff Marsh and Jim McDonald were in attendance. Councilmember Rudy Metayer entered the meeting at 5:06 p.m. Councilmember Mike Heath entered the meeting at 5:11 p.m. Mayor Pro Tem Omar Peña was absent. ### 2. Discuss and consider action

#### **2A.** <u>2018-6896</u>

Discuss and consider action related to the City's Capital Improvement Program and direct the Interim City Manager to begin preparation for related item(s) for a November 6, 2018 Special Election ballot and/or issuance of Certificates of Obligation (CO's).

Ms. Giannini provided information on the proposed roadway projects and discussed with Council. Mr. Fletcher stated that Mike Weaver, Prime Strategies, was in attendance. Mr. Weaver provided information during the discussion regarding applying for CAMPO funds. He recommended grouping planning projects together into a package that are regional in nature for consideration by CAMPO. He recommended that the city review its cost estimates as they are increasing. There was continued discussion with Mr. Weaver.

Discussion continued with Ms. Giannini regarding the list of proposed roadway projects for a possible general obligation bond election. Mr. Weaver suggested 7. Picadilly Drive, 8. Central Commerce Drive, and 9. Royston Lane as a CAMPO package. Discussion with Mr. Weaver, Ms. Giannini and Council

followed.

Discussion followed with Ms. Giannini regarding SH45 frontage roads as a possible general obligation bond project.

Ms. Giannini discussed the proposed list of general obligation street projects for design only.

There was continued discussion with Mr. Weaver regarding alternatives available to staff the City's Capital Improvement Program.

Ms. Gillam provided information on certificates of obligation and general obligation bonds.

Mr. Heath stated that holding a May 2019 bond election may be more prudent. Mayor Gonzales asked if they could leverage their certificates of obligation for CAMPO funding. Ms. Giannini stated yes. Mr. McDonald stated a need to be as proactive as possible.

- 8. Central Commerce Drive design (apply for CAMPO funds)
- 9. Royston Lane- design (apply for CAMPO funds)
- 10. E. Pflugerville Parkway Extension/Realignment of Weiss Lane include
- 11 Melber Lane-design
- 12. Immanuel design and right of way
- 13. Schultz Lane- design and right of way
- 14. Wilke Ridge- design and right of way
- 15. West Black Locust design
- 16. E. Pflugerville Parkway (Colorado Sand to Weiss Lane) preliminary and final design

No action was taken on the item at the special meeting. Action was taken on the item later in the regular meeting.

Mr. Weiss made a motion to close the worksession. Mr. Marsh seconded the motion. All voted in favor. Motion carried. The worksession was adjourned at 7:01 p.m.
