RESOLUTION CALLING A BOND ELECTION FOR NOVEMBER 6, 2018; MAKING PROVISIONS FOR CONDUCTING THE ELECTION; AND RESOLVING OTHER MATTERS RELATED TO SUCH ELECTION

THE STATE OF TEXAS §
COUNTIES OF TRAVIS AND WILLIAMSON §
CITY OF PFLUGERVILLE §

WHEREAS, pursuant to the provisions of Chapters 1251 and 1331, Texas Government Code, as amended, the Texas Election Code, as amended, and other related statutes, the City Council of the City of Pflugerville, Texas (the "City") is authorized to call an election in order to submit to the voters of the City propositions regarding the issuance of tax bonds; and

WHEREAS, the City Council deems it advisable to call a bond election to be held on November 6, 2018 for the propositions hereinafter stated.

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE, TEXAS THAT:

Section 1. ELECTION DATE, POLLING PLACES AND ELECTION JUDGES.

An election shall be held in the City as prescribed by applicable law between the hours of 7:00 A.M. and 7:00 P.M. on November 6, 2018. The City is located in both Travis and Williamson Counties, and the Travis County Clerk and the Williamson County Elections Administrator will each conduct the election for the portion of the City located within their respective boundaries pursuant to separate election agreements (collectively, the "Election Agreements") between the City and Travis County and Williamson County, respectively, as authorized under Section 31.092 of the Texas Election Code. The election shall be held as a joint election pursuant to Chapter 271 of the Texas Election Code and joint election agreements to be entered into between the City and the other participating entities located in Travis and Williamson Counties, respectively, which are holding an election on November 6, 2018. The City election precincts and polling places within the City designated for holding the election shall be determined by Travis County and Williamson County, respectively, and conducted at the polling places attached hereto as Exhibit "A" and such exhibit is incorporated herein by reference for all purposes. The exhibit may be revised as necessary to conform to the final polling locations established by Travis County and Williamson County, as applicable. Travis County's and Williamson County's election equipment, as applicable, shall be used to conduct the bond election. The election judges and clerks shall be appointed in accordance with the Election Agreements and the Texas Election Code, as amended.

Section 2. CONDUCT OF ELECTION. As authorized by Chapter 31, Subchapter D of the Texas Election Code, the City Council hereby appoints the Travis County Clerk, Dana DeBeauvoir, as the election officer for the purpose of conducting the November 6, 2018 election in Travis County and the Williamson County Elections Administrator, Christopher Davis, as the

election officer for the purpose of conducting the November 6, 2018 election in Williamson County. Such appointments include services as Early Voting Clerk for the election, Counting Station Manager, Presiding Judge of the Central Counting Station, and Tabulation Supervisor in their respective counties.

In addition and in accordance with Chapters 66 and 31 of the he Texas Election Code, the City Council hereby appoints the Travis County Clerk, Dana DeBeauvoir, as the agent for the Custodian of Records for the November 6, 2018 election in Travis County and the Williamson County Elections Administrator, Christopher Davis, as the agent for the Custodian of Records for the November 6, 2018 election in Williamson County, each for the purpose of preserving voted ballots and other election records as required by the Texas Election Code in their respective counties.

Section 3. EARLY VOTING. Early voting in the election by personal appearance shall be conducted at the times, dates and polling places as provided for by Travis County and Williamson County, as applicable, attached hereto as Exhibit "B" and such exhibit is incorporated herein by reference for all purposes. The exhibit may be revised as necessary to conform to the final early voting polling locations established by Travis County and Williamson County, as applicable. The Travis County Clerk, Dana DeBeauvoir, is the Early Voting Clerk for the portion of the City located in Travis County, and the Williamson County Elections Administrator, Christopher Davis, is the Early Voting Clerk for the portion of the City located in Williamson County. Applications for ballots by mail for Travis County voters should be sent to Travis County Clerk Elections Division, P.O. Box 149325, Austin, Texas 78714. Application for ballots by mail for Williamson County voters should be sent to Williamson County Early Voting Clerk, P.O. Box 209, Georgetown, Texas 78627.

Section 4. EARLY VOTING BALLOT BOARDS. Early voting ballot boards are hereby created to process early voting results, and the Presiding Judge of the board will be appointed by the Travis County Clerk and the Williamson County Elections Administrator, respectively. The Presiding Judge of each early voting ballot board shall appoint not less than two nor more than eighteen resident, qualified voters to serve as members of such boards.

Section 5. VOTERS. All resident, qualified voters of the City shall be entitled to vote at the election.

Section 6. NOTICE. A substantial copy of this Resolution, with such omissions authorized by law, shall serve as a proper notice of the election. Such notice, including a Spanish translation thereof, shall be posted on the bulletin board used by the City to post notices of meetings and at City Hall not less than twenty-one (21) days prior to the date the election is to be held, and shall remain posted through election day. In addition to the foregoing, this Resolution, including a Spanish translation thereof, shall be (i) posted on election day and during early voting by personal appearance in a prominent location at each polling place; (ii) posted in three (3) public places in the boundaries of the City no later than twenty-one (21) days before the election; and (iii) posted on the City's Internet website during the twenty-one (21) days before the election if the City maintains an Internet website.

Such notice, including a Spanish translation thereof, shall be published in the *Pflugerville Pflag*, a newspaper of general circulation in the City, on the same day in each of two successive weeks with the first publication occurring not earlier than the thirtieth (30th) day or later than the fourteenth (14th) day prior to the day of the election.

The City Secretary is hereby authorized and directed to publish and post the required notices in the manner and for the time periods required by law.

Section 7. VOTING DEVICES. In all respects, the election shall be conducted in accordance with the Texas Election Code and the Federal Help America Vote Act. Every polling place used in both Travis County and Williamson County for the election will have at least one disabled access voting device such as a Direct Recording Electronic voting device available for election day voting and early voting. The Williamson County Voter Registrar and the Travis County Voter Registrar, respectively, may also utilize a central counting station as provided by Section 127.000 *et seq.*, as amended, Texas Election Code. Any central counting station presiding judge and the alternate presiding judge shall be appointed in accordance with the Election Agreement and the Texas Election Code.

Section 8. PROPOSITIONS. At the election, the following PROPOSITIONS shall be submitted in accordance with law:

PROPOSITION A

"Shall the City Council of the City of Pflugerville, Texas, be authorized to issue bonds of the City, in one or more series or issues, in the aggregate principal amount of \$4,290,000 with the bonds of each such series or issues, respectively, to mature serially within not to exceed forty years from their date, and to be sold at such prices and bear interest at such rates, as shall be determined within the discretion of the City Council, in accordance with law at the time of issuance, for the purpose of constructing, improving, extending, expanding, upgrading and/or developing Colorado Sand Drive, including utility relocation, sidewalks, traffic safety and operational improvements, the purchase of any necessary rights-of-way, design costs and related drainage and other related costs; and shall said City Council be authorized to levy and cause to be assessed and collected annual ad valorem taxes on all taxable property in the City in an amount sufficient to pay the annual interest on said bonds and provide a sinking fund to pay the bonds at maturity?"

CITY OF PFLUGERVILLE, TEXAS
PROPOSITION B

"Shall the City Council of the City of Pflugerville, Texas, be authorized to issue bonds of the City, in one or more series or issues, in the aggregate principal amount of \$7,810,000 with the bonds of each such series or issues, respectively, to

mature serially within not to exceed forty years from their date, and to be sold at such prices and bear interest at such rates, as shall be determined within the discretion of the City Council, in accordance with law at the time of issuance, for the purpose of constructing, improving, extending, expanding, upgrading and/or developing Kelly Lane, including utility relocation, sidewalks, traffic safety and operational improvements, the purchase of any necessary rights-of-way, design costs and related drainage and other related costs; and shall said City Council be authorized to levy and cause to be assessed and collected annual ad valorem taxes on all taxable property in the City in an amount sufficient to pay the annual interest on said bonds and provide a sinking fund to pay the bonds at maturity?"

CITY OF PFLUGERVILLE, TEXAS
PROPOSITION C

"Shall the City Council of the City of Pflugerville, Texas, be authorized to issue bonds of the City, in one or more series or issues, in the aggregate principal amount of \$4,010,000 with the bonds of each such series or issues, respectively, to mature serially within not to exceed forty years from their date, and to be sold at such prices and bear interest at such rates, as shall be determined within the discretion of the City Council, in accordance with law at the time of issuance, for the purpose of constructing, improving, extending, expanding, upgrading and/or developing Old Austin Hutto Road, including utility relocation, sidewalks, traffic safety and operational improvements, the purchase of any necessary rights-of-way, design costs and related drainage and other related costs; and shall said City Council be authorized to levy and cause to be assessed and collected annual ad valorem taxes on all taxable property in the City in an amount sufficient to pay the annual interest on said bonds and provide a sinking fund to pay the bonds at maturity?"

CITY OF PFLUGERVILLE, TEXAS
PROPOSITION D

"Shall the City Council of the City of Pflugerville, Texas, be authorized to issue bonds of the City, in one or more series or issues, in the aggregate principal amount of \$5,030,000 with the bonds of each such series or issues, respectively, to mature serially within not to exceed forty years from their date, and to be sold at such prices and bear interest at such rates, as shall be determined within the discretion of the City Council, in accordance with law at the time of issuance, for the purpose of constructing, improving, extending, expanding, upgrading and/or developing East Pflugerville Parkway, including utility relocation, sidewalks, traffic safety and operational improvements, the purchase of any necessary rights-of-way, design costs and related drainage and other related costs; and shall said City Council be authorized to levy and cause to be assessed and collected annual ad valorem taxes on all taxable property in the City in an amount sufficient to pay the annual interest on said bonds and provide a sinking fund to pay the bonds at maturity?"

Section 9. OFFICIAL BALLOTS. Voting in the election for the propositions shall be by the use of electronic or paper ballots which shall show the propositions in both English and Spanish and which shall conform to the requirements of federal law, including the Help America Vote Act, and the Texas Election Code, as amended. The official ballots for the election shall be prepared in accordance with the Texas Election Code so as to permit the voters to vote "FOR" or "AGAINST" on the PROPOSITIONS with the ballots to contain such provisions, markings and language as required by law, and with such PROPOSITIONS to be expressed substantially as follows:

PROPOSITION B

FOR () THE ISSUANCE OF \$7,810,000 TAX BONDS FOR STREET
AGAINST () IMPROVEMENTS TO KELLY LANE

CITY OF PFLUGERVILLE, TEXAS
PROPOSITION C

FOR () THE ISSUANCE OF \$4,010,000 TAX BONDS FOR STREET
AGAINST () IMPROVEMENTS TO OLD AUSTIN HUTTO ROAD

CITY OF PFLUGERVILLE, TEXAS
PROPOSITION D

FOR () THE ISSUANCE OF \$5,030,000 TAX BONDS FOR STREET
AGAINST () IMPROVEMENTS TO EAST PFLUGERVILLE PARKWAY

Section 10. CONDUCT IN ACCORDANCE WITH LAW. In all respects the election shall be conducted in accordance with State and federal law including the Texas Election Code and the Help America Vote Act.

Section 11. RESULTS. The Travis County Voter Registrar and the Williamson County Voter Registrar, respectively, shall conduct an unofficial tabulation of results after the closing of the polls on November 6, 2018. The official canvass and tabulation of the results of the bond election shall be conducted by the City Council at a City Council meeting held in accordance with the Texas Election Code.

Section 12. MISCELLANEOUS PROVISIONS.

The provisions of this Resolution are severable; and in case any one or more of the provisions of this Resolution or the application thereof to any person or circumstance should be held to be invalid, unconstitutional, or ineffective as to any person or circumstance, the remainder of this Resolution nevertheless shall be valid, and the application of any such invalid provision to persons or circumstances other than those as to which it is held invalid shall not be affected thereby.

The City Council hereby finds and declares that written notice of the date, hour, place and subject of the meeting at which this Resolution was adopted was posted and that such meeting was open to the public as required by law at all times during which this Resolution and the subject matter hereof were discussed, considered and formally acted upon, all in accordance with and as required by the Open Meetings Act, Chapter 551, Texas Government Code, as amended.

In accordance with the provisions of Section 3.009(b), Texas Election Code, it is hereby found and determined that:

- (a) The proposition language that will appear on the ballot is set forth in Section 9 hereof.
- (b) The purpose for which the bonds are to be authorized is set forth in Section 8 hereof.
- (c) The principal amount of the bonds to be authorized is set forth in Sections 8 and 9 hereof.
- (d) As set forth in Sections 8 and 9 hereof, if the bonds are approved by the voters, the City Council will be authorized to impose and levy annual ad valorem taxes, on all taxable property in the City, sufficient, without limit as to rate or amount, to pay the principal of and interest on the bonds.
- (e) Based upon the bond market conditions at the date of adoption of this Resolution, the maximum interest rate for any series of the bonds is estimated to be 4.5% per annum as calculated in accordance with applicable law. Such estimate is based on advice received from the City's financial advisor, which advice takes into account a number of factors, including the issuance schedule, maturity schedule and the expected bond ratings of the proposed bonds. Such estimated maximum

interest rate is provided as a matter of information, but is not a limitation on the interest rate at which the bonds, or any series thereof, may be sold.

(f) As set forth in Section 8 hereof, if the bonds are approved, they may be issued in one or more series, to mature over a period not to exceed 40 years.

(g) The aggregate amount of the outstanding principal of the City's debt secured by ad valorem taxes as of the beginning of the City's 2017-18 fiscal year was \$216,495,000.

(h) The aggregate amount of the outstanding interest on the City's debt secured by ad valorem taxes as of the beginning of the City's 2017-18 fiscal year was \$114,378,597.

(i) The ad valorem debt service tax rate for the City for the 2017-18 fiscal year is \$0.2054 per \$100 of taxable assessed valuation.

This information is provided in this section is solely for purposes of compliance with Section 3.009(b) of the Texas Election Code and is for illustration purposes only. The information is not a part of the propositions to be voted on and does not create a contract with the voters.

13. PROVISIONS. The provisions of this Resolution are severable; and in case any one or more of the provisions of this Resolution or the application thereof to any person or circumstance should be held to be invalid, unconstitutional, or ineffective as to any person or circumstance, the remainder of this Resolution nevertheless shall be valid, and the application of any such invalid provision to persons or circumstances other than those as to which it is held invalid shall not be affected thereby. The Mayor and the City Secretary are authorized and directed to take any action necessary to carry out the provisions of this Resolution.
