Plan that was drafted by Staff and City Council Subcommittee consisting of Mayor Gonzales, Councilmember Marsh, and Councilmember Weiss. She walked thru the downtown planning history and talked about the efforts of the City Council Subcommittee. She talked about the intent of the Action Plan and what makes a great place. She went thru the goals of the Action Plan and proposed timeline for reaching these goals. She also talked about proposed Code Amendments and how they will help achieve the goals outlined. Ms. Sellers answered the questions of Commission regarding the proposed Downtown Action Plan and received positive feedback. No recommendation was made to City Council.
