AN ORDINANCE OF THE CITY OF PFLUGERVILLE, TEXAS, AMENDING THE CITY OF PFLUGERVILLE, TEXAS CODE OF ORDINANCES, CHAPTER 72 BY SUPPLEMENTING SCHEDULE III REGARDING STOP SIGNS ON CITY STREETS, PROVIDING FOR A PENALTY FOR A VIOLATION OF CHAPTER 72 AS A CLASS C MISDEMEANOR AND A FINE IN AN AMOUNT NOT TO EXCEED \$200.00; REPEALING ALL ORDINANCES TO THE EXTENT THEY ARE IN CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Pflugerville desires to continue to protect and ensure the public health, safety, and welfare of its residents and businesses by regulating and guiding road users for the protection of the general travelling public; and

WHEREAS, the City of Pflugerville is authorized by Title 7, Subchapter C of the Texas Transportation Code to establish and regulate compliance with rules governing the use of public thoroughfares; and

WHEREAS, the City Council desires to amend and supplement its regulations as provided by and consistent with Texas law.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE, TEXAS:

<u>Section 1. Findings</u>. The foregoing recitals are hereby found to be true and correct and are hereby adopted by the City Council and made a part hereof for all purposes and findings of fact.

<u>Section 2</u>. Chapter 72, Schedule III of the City of Pflugerville, Texas Code of Ordinances is hereby amended by supplementing Schedule III and the current table with the following:

SCHEDULE III. STOP SIGNS ON PUBLIC STREETS

The following stop signs are approved in addition to those previously approved by plat:

A stop sign at the southeast corner of Pleasant Bay Drive facing south at its intersection with Kelly Lane.

A stop sign at the northeast corner of Pleasanton Parkway facing east at its intersection with Weiss Lane.

Carmel West Subdivision

A stop sign at the southeast corner of Benica Street facing south at its intersection with Pleasanton Parkway.

A stop sign at the northeast corner of Benica Street facing north at its intersection with Anaheim Avenue.

A stop sign at the southwest corner of Anaheim Avenue facing west at its intersection with Benica Street.

A stop sign at the northeast corner of Anaheim avenue facing east at its intersection with El Sinore lane.

A stop sign at the southeast corner of El Sinore Lane facing south at its intersection with Pleasanton Parkway.

A stop sign at the southwest corner of Folsom Avenue facing west at its intersection with Athrop Avenue.

A stop sign at the Northeast corner of Folsom Avenue facing east at intersection with Athrop Avenue.

A stop at the southwest corner of Folsom Avenue facing west at its intersection with Borromeo Ave.

A stop sign at the northeast corner of Folsom Avenue facing east at its intersection with Borromeo Ave.

A stop sign at the southeast corner of Athrop Avenue facing south at its intersection with Wolf Pack Drive.

A stop sign at the southeast corner of Casanova Avenue facing south at its intersection with Wolf Pack Drive.

A stop sign at the northwest corner of Casanova Avenue facing north at its intersection with Wolf Pack Drive.

Falcon Pointe Subdivision

A stop sign at the northeast corner of Falcon Village Lane facing east at its intersection with Colorado Sand Drive.

A stop sign at the southwest corner of Falcon Village Lane facing west at its intersection with Colorado Sand Drive.

A stop sign at the northeast corner of Falcon Village Lane facing east at its intersection with the northbound State Highway 130 access road.

Highland Park Subdivision

A stop sign at the northwest corner of Atoctin Drive facing north at its intersection with Craters of the Moon Blvd.

A stop sign at the northwest corner of Cumberland Gap facing north at its intersection with Craters of the Moon Blvd.

A stop sign at the northwest corner of Conagree Street facing north at its intersection with Craters of the Moon Blvd.

A stop sign at the southeast corner of Conagree Street facing south at its intersection with Cane River Drive.

A stop sign at the northwest corner of Cuyahoga Drive facing north at its intersection with Craters of the Moon Blvd.

A stop sign at the southeast corner of Cuyahoga Drive facing south at its intersection with Cane Rover Drive.

A stop sign at the northeast corner of Craters of the Moon Blvd facing east at its intersection with N Heatherwilde.

A stop sign at the northeast corner of Cane River Drive facing east at its intersection with N Heatherwilde.

A stop sign at the southwest corner of Cumberland Gap Street facing south at its intersection with Cane River Road.

A stop sign at the southwest corner of Craters of the Moon facing west at its intersection with Kingston Lacy Blvd.

Penley Park Subdivision

A stop sign at the northeast corner of Speckled Alder Drive facing east at its intersection with Peach Vista Drive

A stop sign at the northeast corner of Coconut Grove Street facing east at its intersection with Peach Vista Drive

A stop sign at the southwest corner of Speckled Alder Drive facing west at its intersection with Navarre Terrace.

A stop sign at the southwest corner of Coconut Grove Street facing west at its intersection with Navarre Terrace.

A stop sign at the southwest corner of Tinton Falls Lane facing west at its intersection with Navarre Terrace.

A stop sign at the southeast corner of Penley Reserve Pass facing south at its intersection with Coconut Grove Street.

A stop sign at the southwest corner of Valhalla Lane facing west at its intersection with Vista Verde Drive.

A stop sign at the southwest corner of Brazos Lane facing west at its intersection with Vista Verde Drive.

A stop sign at the northeast corner of Valhalla Lane facing west at its intersection with Peach Vista Drive.

A stop sign at the northeast corner of Brazos Lane facing west at its intersection with Peach Vista Drive.

Shops at 685 Subdivision

A stop sign at the southeast corner of Terrell Lane facing south at its intersection with Town Center Drive.

A stop sign at the northeast corner of the private drive facing east at its intersection with Terrell Lane.

Swenson Farms Subdivision

A stop sign at the northeast corner of Private Kaden Prince Drive facing east at its intersection with Swenson Farms Blvd.

A stop sign at the northeast corner of Private Landon Samuel Loop facing east at its intersection with Swenson Farms Blvd.

Verona Subdivision

A stop sign at the northwest corner of Scoria Drive facing north at its intersection with Obsidian Drive

A stop sign at the southeast corner of Scoria Drive facing south at its intersection with Obsidian Drive

A stop sign at the northwest corner of Quebrada Ave facing north at its intersection with Obsidian Drive.

A stop sign at the southeast corner of Quebrada Ave facing south at its intersection with Obsidian Drive.

A stop sign at the northwest corner of Kimberlite Drive facing north at its intersection with Obsidian Drive.

A stop sign at the south east corner of Kimberlite Drive facing south at its intersection with Obsidian Drive.

A stop sign at the southeast corner of Quebrada Drive facing south at its intersection with Cele Road.

A stop sign at the northeast corner of Gabbro Drive facing east at its intersection with Quebrada Drive.

A stop sign at the southwest corner of Gabbro Drive facing west at its intersection with Quebrada Drive.

A stop sign at the southwest corner of Brittle Lane facing west at its intersection with Quebrada Drive.

A stop sign at the northeast corner of Gabbro Drive facing east at its intersection with Elk Horn Drive.

A stop sign at the northeast corner of Brittle Lane facing east at its intersection with Elk Horn Drive.

A stop sign at the southeast corner of Rookery Trail facing south at its intersection with Brittle Lane.

A stop sign at the southeast corner of Kimberlite Drive facing south at its intersection with Brittle Lane.

A stop sign at the northwest corner of Rookery Trail facing south at its intersection with Obsidian Drive.

A stop sign at the northeast corner of Obsidian Drive facing east at its intersection with Elk Horn Drive.

Village on Legacy Subdivision

A stop sign at the northeast corner of Beechtree Lane facing east at its intersection with Warm Springs Drive.

A stop sign at the southeast corner of Aspen Grove Drive facing south at its intersection with Beechtree Lane.

A stop sign at the southeast corner of Legacy Drive facing south at its intersection with Aspen Grove Drive.

A stop sign at the northwest corner of Legacy Drive facing north at its intersection with W. Pfennig Lane.

Section 3. Penalty. That a violation of this Ordinance shall be an offense punishable upon conviction as prescribed in Title VII, Chapter 70, Section 70.99 of this Code of Ordinances.

Section 4. Severability. If any provision of this Ordinance is illegal, invalid, or unenforceable under present or future laws, the remainder of this Ordinance will not be affected and, in lieu of each illegal, invalid, or unenforceable provision, a provision as similar in terms to

the illegal, invalid, or unenforceable provision as is possible and is legal, valid, and enforceable will be added to this Ordinance.

Section 5. Repealer. This ordinance shall be cumulative of all other ordinances of the City of Pflugerville, and this ordinance shall not operate to repeal or affect any other ordinances of the City of Pflugerville except insofar as the provisions thereof might be inconsistent or in conflict with the provisions of this ordinance, in which event such conflicting provisions, if any, are hereby repealed.

Section 6. Effective Date. This Ordinance will take effect upon its adoption by the City Council in accordance with Section 3.15(d) of the City Charter.
