Worksession

1. Call to order

Discussion regarding the City Manager's Organizational Plan.

Ms. Breland provided some history of strategic planning efforts at the city and spoke regarding her organizational plan. She asked what direction the Council would like to take in regards to strategic planning. Council discussion followed with Ms. Breland. Council was to discuss a strategic plan, mission and values at a future retreat worksession.

Discussion regarding creation of a Parks & Recreation Advisory Board for the Senior Center and Recreation Center Needs Assessment and Feasibility Study.

Mr. Hemenes provided information. He stated that Brinkley Sargent Wiginton Architects has completed most of the preliminary data collection and is ready to proceed with the next phases of the project. He stated that they think this is a great project for appointing a Parks Advisory Board. Each Councilmember was to bring a name forward for appointment to the January 22, 2019 Regular Council meeting.

Discuss proposed Non-Radioactive Hazardous Materials Route Designation Plan.

Annick Beaudet, Assistant Director of the City of Austin Transportation Department, provided information. Jim Harvey, Alliance Transportation Group, provided more detailed information on defining the network, risk analysis and routing options, presentations given, and stakeholder and public feedback

received. Discussion followed. Mayor Pro Tem Peña and Councilmember Metayer stated a need to include the Travis County Emergency Services District No. 2 in the planning. Mr. Weiss and Mr. Marsh stated concerns with the plan. Mr. Marsh indicated frustration with the City of Austin deciding that this should go through Pflugerville. Ms. Breland stated that the Council would not be voting on the plan. Mr. Fletcher stated that comments could be submitted.

Mr. Weiss made a motion to close the worksession. Mr. McDonald seconded the motion. All voted in favor. The motion carried. The worksession was adjourned at 7:01 p.m.
