Agenda Item Description for City of Pflugerville, March 26, 2019 City Council Meeting

Title: Discuss and action approving a contract between the Pflugerville Community Development Corporation (PCDC) and Avalanche Consulting for development of a Comprehensive Economic Development Strategy (CEDS 2.0) in FY19 presented by Amy Madison, PCDC Executive Director.

Summary: The PCDC Board requests approval of the contract between PCDC and Avalanche Consulting to complete an expanded economic development strategy in FY19. The CEDS 2.0 will be presented to the PCDC Board and City Council in the summer of 2019. The schedule for the plan is included on the summary document and in the agreement. The process will include community engagement and increased input from the PCDC Board, City Staff, and City Council prior to adoption.

Status: The PCDC completed their CEDS 1.0 earlier this year. It was a 3-year plan, but due to the focus on implementation, it was completed in 2 years. The Board anticipated the completion and the need for an updated study and set aside \$100,000 in the PCDC budget for this purpose. The PCDC budget was approved by the City Council in August 2018.

In February 2019, PCDC sent out a request for proposal for CEDS 2.0. Three proposals were received and evaluated by the PCDC staff and Board. The consulting agreement between Avalanche Consulting and Pflugerville Community Development Corporation was approved unanimously by the PCDC Board on Wednesday, February 20, 2019.

Prior City Council Action: City Council approved the previous CEDS agreement in 2017, and the PCDC FY19 budget which included funding for this purpose.

Deadline for City Council Action: Consideration requested for March 26, 2019 Regular Council Meeting.

Fiscal Impact: No further impact. \$100,000 was budgeted in the previously approved FY2019 budget by PCDC Board and City Council.

Staff Recommendation: The PCDC Board and staff recommend approval.

Timetable & Budget

The proposed scope will cost \$99,500 including expenses. This includes four trips to Pflugerville and two half day trips to present at a PCDC Board Meeting and City Council Meeting.

If PCDC desires one of Avalanche's site selection partners to conduct a more indepth evaluation of sites and infrastructure, the total project cost will be \$119,500 including expenses.

Additional trips for City Council meetings or other needs are available at a cost of \$3,000 plus expenses per day per consultant.
