**RESOLUTION OF THE CITY OF PFLUGERVILLE SUPPORTING AN ANNUAL COMMUNITY ENGAGEMENT PROJECT AND AUTHORIZING THE CITY MANAGER TO ANNUALLY CREATE AND FACILITATE THE SAME**

WHEREAS, the City Council of the City of Pflugerville has determined that it is necessary and beneficial to organize and facilitate an annual community engagement project that articulates the City's values and identity, contributes to the community's sense of place and cohesiveness, and promotes quality of life, community wellbeing, partnerships, leadership, and service to the community; and

WHEREAS, an annual community engagement project is contemplated and supported by the 2030 Comprehensive Plan's Recreation and Parkland Policy 1.2 whereby the City is to proactively solicit partnerships and coordinate the provision of parks and recreational programs with other governmental bodies, community organizations, and private entities; and

WHEREAS, in accordance with the 2030 Comprehensive Plan's economic development action item 1.2.1, the first annual community engagement project, "Main Street Plazapalooza", is intended to support the efforts of property owners and local business organizations in revitalization efforts in Downtown consistent with the Downtown Vision; and

WHEREAS, pursuant to the City's Downtown Action Plan (2019-2021), Main Street Plazapalooza is envisioned to provide for the creation of an outdoor gathering place contributing to increased vibrancy and a distinct sense of place; and

WHEREAS, the City Council of the City of Pflugerville has determined that it is necessary and beneficial to facilitate community building efforts that directly and indirectly affect the community's health, economic development opportunities, and image.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE:

**Section 1.**

That the foregoing recitals are hereby found to be true and correct and are hereby adopted by the City Council and made a part hereof for all purposes and findings of fact.

**Section 2.**

That the City Council of the City of Pflugerville, Texas hereby supports and is resolute in its position that an annual community engagement project will facilitate the building of a healthy and active community and, further, hereby authorizes and directs the City Manager to create and facilitate the Main Street Plazapalooza event contemplated herein and annual community engagement projects thereafter to the extent authorized by law and budgetary appropriations governing and providing for the same.

**Section 3.**

That this Resolution shall be in full force and effect from and after its passage and adoption.


