Unit passes a 4" solid and is rated for 2400 GPM @146' TDH. One pump running duty condition is 4200 GPM @ 93' TDH.**

**3ea 2" thick x 10" x 8" carbon steel adapter flanges with SS hardware to adapt to existing KSB 8" guiderail bracket.**

**The quoted pump / bracket will retrofit directly onto the existing guide rail system / pedestal elbows.**
