Joint Meeting with the Pflugerville Community Development Corporation Board

Discuss and consider action to authorize the City Manager to execute conditional purchase agreements, easement purchase agreements and associated conveyance documents between The Timmerman & Hagn Ltd. for Wastewater Line Easements and Temporary Construction Easements (TCE's) - Parcels 2, 4, 5, 6, 7 and 10, The Timmerman Farms, Ltd. for Wastewater Line Easement and TCE, Parcel 11, The Hagn & Timmerman Ltd. for Buffer Zone Easement, Parcel 8, and The Hagn & Timmerman Ltd. for Wastewater Line Easement, Laydown area/TCE and Water Line Easement. Parcel 8 and the City of Pflugerville as necessary to acquire real property interests for the West SH130 Wastewater Interceptor Phase 1 and Phase 2 projects generally located along Wilbarger Creek between the Central Wastewater Treatment Plant and East Pflugerville Parkway.

Mr. Fletcher provided information. Gordon Pate, Lockwood, Andrews & Newnam, Inc. answered questions and discussion followed. Mr. Metayer verified that applicable appraisals were accepted. Mr. Metayer made a motion to approve. Mr. Heath seconded the motion. There was continued discussion with Mr. Pate. All voted in favor. The motion carried.
