Mr. McDonald asked what the issue is that they are trying to solve. Mayor Pro Tem Peña stated that he sees only a pipeline view of what the PCDC is working on. Mr. McDonald stated that Mayor Pro Tem Peña is welcome to attend the PCDC meetings when these items are discussed. Mr. Metayer stated that he believes that this will be a longer discussion.
