RESOLUTION OF THE CITY OF PFLUGERVILLE, TEXAS AUTHORIZING THE CITY MANAGER TO RECONCILE FINAL PROJECT COSTS AND REIMBURSE MANVILLE WATER SUPPLY CORPORATION FOR THE FINAL COST OF CONSTRUCITON OF A 12-INCH WATER LINE INSTALLED ALONG EAST PFLUGERVILLE PARKWAY

WHEREAS, the City of Pflugerville and Manville Water Supply Corporation (Manville) entered into that certain Contract for the Purchase and Sale of Wholesale Water, for the Termination of Pre-Existing Contracts, and Related Matters, dated March 19, 2014; and

WHEREAS, a requirement of the Contract was for the City to allow Manville, at the sole expense of the city, to construct a 12" Waterline along East Pflugerville Parkway, to the east side of FM 685; and

WHEREAS, the infrastructure is estimated to require 6,800 linear feet of twelve inch water line to transport six-hundred-eighty-five thousand (685,000) gallons of water per day, to be owned by Manville, upon completion of construction, Manville will accept the work and request reimbursement from the City for the full cost and all expenses of the work; and

WHEREAS, any expense incurred by Manville for the infrastructure to implement the Contract as referenced in section 2.03 and 2.04 shall be approved by the City prior to expense being made; and

WHEREAS, the Manville Water Supply Corporation (MWSC) advertised bids using their procedures on August 13, 2019 to secure construction services for the MWSC 12" Waterline Project along East Pflugerville Parkway, in the City of Pflugerville, Texas; and

WHEREAS, the City of Pflugerville authorized the award of the bid, to Nelson Lewis, and construction of the project on September 10, 2019 and accepted responsibility for reimbursement of the project cost of construction under the Contract; and

WHEREAS, Nelson Lewis, started construction of the 12-inch water line in November 2019 and completed construction in May 2020; and

WHEREAS, Manville Water Supply Corporation accepted the project on July 31, 2020 and is requesting reimbursement in the amount of \$1,125,111.50 as the final project cost subject to reconciliation of project costs by the City.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE, TEXAS:

- 1. That the above recitals are hereby found to be true and correct by the City Council of the City of Pflugerville and incorporated herein for all purposes.
- 2. The City Council hereby authorizes the City Manager to review and execute any and all documents necessary to conduct a final reconciliation of project costs and reimburse
