

**ORDINANCE NO. \_\_\_\_\_**

**AN ORDINANCE OF THE CITY OF PFLUGERVILLE AMENDING TITLE IX, CHAPTER 90 ANIMALS BY REPEALING AND REPLACING SAID CHAPTER; REPLACING ALL ORDINANCES IN CONFLICT; CONTAINING SEVERABILITY AND REPEALER CLAUSES; PROVIDING FOR A PENALTY FOR A VIOLATION OF CHAPTER 90, AS A CLASS C MISDEMEANOR AND A FINE IN AN AMOUNT NOT TO EXCEED \$500.00; AND DECLARING AN EFFECTIVE DATE.**

**WHEREAS**, the City Council previously adopted animal regulations; and

**WHEREAS**, the City Council has determined that it is necessary to update and amend the codes from time to time to ensure the realization of its stated purposes and its compliance with applicable State law; and

**WHEREAS**, due to the extent of reorganization and substantial modifications to the animal regulations, the City has determined that it is necessary to repeal and replace the Animal Code; and

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE, TEXAS:**

**Section I. Findings.**

That the foregoing recitals are hereby found to be true and correct and are hereby adopted by the City Council and made a part hereof for all purposes and findings of fact.

**Section II. Repeal and Replace.**

That the Code of Ordinances of the City of Pflugerville, Texas, is hereby amended by repealing and replacing Chapter 90, animals, in its entirety, to read as provided in Exhibit A, attached hereto and incorporated herein for all purposes.

**Section III. Severability.**

If any provision of this Ordinance is illegal, invalid, or unenforceable under present or future laws, the remainder of this Ordinance will not be affected and, in lieu of each illegal, invalid, or unenforceable provision, a provision as similar in terms to the illegal, invalid, or unenforceable provision as is possible and is legal, valid, and enforceable will be added to this Ordinance.

**Section IV. Repealer.**

This ordinance shall be cumulative of all other ordinances, resolutions or acts of the City of Pflugerville, and this ordinance shall not operate to repeal or affect any other ordinances of the City of Pflugerville except insofar as the provisions thereof might be

inconsistent or in conflict with the provisions of this ordinance, in which event such conflicting provisions, if any, are hereby repealed.

**Section VI Violation.**

That a violation of this Ordinance shall be an offense punishable upon conviction by fine in an amount not to exceed \$500.00 and as otherwise as prescribed in Chapter 10 of the City's Code of Ordinances.

**Section VII. Effective Date.**

This Ordinance will take effect upon its adoption by the City Council and publication of the caption hereof in accordance with Section 3.15(d) of the City Charter.
