Proposition

The issuance of **\$42,300,000 bonds** by the City of Pflugerville, Texas, for parks and recreation projects for trail improvements, neighborhood parks, land acquisition, Lake Pflugerville, 1849 Park, and destination play space. The **\$42.3 million** bond is estimated to cost **\$16.38** per \$100,000 home valuation.



Overview

- The City issued a Request for Qualifications (RFQs) for general consulting services on November 11th.
- The City received eight (8) Statements of Qualifications (SOQs) from interested firms on December 17th.
- A Selection Committee made up of City Staff reviewed and scored the SOQs based on the RFQ scoring criteria.
- The top three (3) firms based on the SOQ scoring were interviewed by the Selection Committee on January 14th.
