## CITY OF PFLUGERVILLE INVITATION FOR BIDS

City of Pflugerville, Texas County of Travis

Separate sealed bids addressed to the City of Pflugerville, will be received until 2:00 P.M. on July 29, 2021 at the City of Pflugerville City Hall, 100 East Main, Suite 100, Pflugerville, Texas 78660 at which time they will be publicly opened and read aloud at Suite 500, for furnishing all labor; material, tools and equipment and performing all work required for the Weiss Lane Lift Station Riser Column Repair which consists of bypass pumping, removal and replacement of Pump # 1, Pump # 2, and Pump # 3's 12-inch riser pipes, and removal and replacement of guiderail system for Pump # 1 & Pump # 3.

Bids must be submitted on the Proposal and Bid Schedule forms provided and must be accompanied by a bid security in a penal sum of not less than five percent (5%) of the total amount of the bid submittal. The security may be in the form of a certified check, cashier's check or bid bond furnished by a reliable surety company having authority under the laws of Texas to write surety bonds in the amount required, with such security made payable without recourse to the City. The envelope containing the bid shall indicate clearly on the front that it is a bid for Weiss Lane Lift Station Riser Column Repair.

The final Notice of Award of Contract shall be issued to the successful bidder by the City within sixty (60) days following the opening of bids and no bidder may withdraw a bid within sixty (60) days after opening thereof. The successful Bidder must furnish a performance bond and payment bond on the forms provided, each in the amount of one hundred percent (100%) of the contract amount, from a surety company authorized by the State of Texas to act as surety.

State statutes, including Prevailing wage and hour provisions and contract regulations must be adhered to as they relate to this Project. Contractors will be required to comply with all applicable Equal Employment Opportunity laws and regulations.
