#### Worksession

Mr. Hyde reviewed and discussed the proposed changes to the document that were previously suggested. Mr. Hyde was to bring back to Council on May 9, 2017 for consideration.

**2B.** ORD-0357 Discussion regarding Council reimbursement policy. (Requested by Councilmember Jeff Marsh)

Mr. Weiss stated that he would like to add the requirement for pre-approval for out of state travel. Discussion followed. Mr. Heath stated that he also thinks that reimbursement requests should be made within 30 days of travel and should include beginning and end destinations and a mileage log. Mr. Heath stated that he does not like the per dium and thinks that they need to provide receipts and that there be a maximum allowed per day. Discussion continued with Mr. Hyde.
