Regular Meeting

1. Call to order

Mayor Victor Gonzales called the regular meeting to order at 7:15 p.m.

Councilmembers Doug Weiss, Jeff Marsh, Omar Peña, Starlet Sattler and Mike Heath were in attendance. 2. Opening

4. Public Comment

Ms. Vernagene Mott, Pflugerville Independent School District Board of Trustees President, is expected to provide comments regarding the progress of road construction on East Pecan Street and Weiss Lane.

Ms. Mott expressed appreciation to the city for the improvements to Heatherwilde and Weiss Lane. She stated that she hopes to collaborate and look at infrastructure in the future.

Brian Allen, Commander, American Legion Post 154, is expected to provide comments with appreciation to the City for providing active military and veterans with additional parks and recreation benefits.

Mr. Allen thanked the City for supporting our veterans by providing parks benefits, providing for the placement of a flag at the Recreational Center, coordinating the visiting Vietnam Veterans Wall and providing support during the Veterans Ceremony. He spoke on the contributions of the American Legion Post 154 to the community.

Approving an ordinance on first reading with the caption reading: AN ORDINANCE OF THE CITY OF PFLUGERVILLE, TEXAS, ADOPTING THE SECOND AMENDMENT TO THE FISCAL YEAR 2017 BUDGET FOR THE CITY OF PFLUGERVILLE; AND PROVIDING AN EFFECTIVE DATE.

The ordinance was approved on first reading on the consent agenda.

The ordinance was approved on second and final reading on the consent agenda.

9H. 2017-5820 Approving an agreement with HVJ Associates, Inc. in the amount of

\$78,065 for professional engineering services associated with the design, bidding, construction administration, and material testing for the Grand Avenue Parkway Pavement Maintenance Project and

authorizing the City Manager to execute the agreement.

The item was approved on the consent agenda.

Approving an ordinance on second reading with a caption reading: AN ORDINANCE OF THE CITY OF PFLUGERVILLE, TEXAS, AMENDING ORDINANCE NO. 1203-15-02-24 OF THE CITY OF PFLUGERVILLE, TEXAS, AS AMENDED, BY CHANGING THE ZONING DESIGNATION OF AN APPROXIMATE 5.964 ACRE TRACT OF LAND OUT OF THE JOHN VAN WINKLE SURVEY NO. 14, LOCATED GENERALLY SOUTHEAST OF THE BLACK LOCUST DR. AND GRAND AVE. PKWY INTERSECTION FROM AGRICULTURE/CONSERVATION (A) TO MULTI-FAMILY 10 (MF-10) DISTRICT; TO BE KNOWN AS THE WINDERMERE PARK GARDEN VILLAS SECTION TWO REZONING (REZ1701-01); PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

Mr. Weiss stated that this allows for 60 homes on a collector with 100 feet of access and no traffic mitigation plans. Mayor Pro Tem Peña made a motion to approve as presented. Ms. Sattler seconded the motion. The

vote was: Mr. Weiss-no, Mr. Marsh-yes, Mayor Pro Tem Peña-yes, Ms. Sattler-yes; Mr. Heath-no, Mayor Gonzales-yes. The motion carried.

8. Resolution - Removed from the Consent Agenda

8A. RES-0422

Approving a resolution with the caption reading: A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE, TEXAS, REJECTING ALL BIDS RECEIVED FOR THE PFLUGERVILLE ANIMAL WELFARE SERVICES (PAWS) INTAKE BUILDING.

Mr. Fletcher stated that staff is evaluating the scope to reduce the cost. He indicated plans to bring back a new bid for consideration in 90 days. Mr. Heath requested a presentation to review the scope at a future worksession. Mr Peña made a motion to approve the resolution as presented. Ms. Sattler seconded the motion. All voted in favor. The motion carried.

9. Other Actions

9F. 2017-5831

Approving budget amendments for the Pflugerville Community Development Corporation fiscal year 2017, 2nd quarter.

Karla Henderson, Pflugerville Community Development Corporation (PCDC) Finance and Operations Manager, provided an overview of the requested budget amendments and answered questions of the Council. Mr. Weiss, PCDC Boardmember, also provided input. Mr. Weiss made a motion to approve the item as presented. Ms. Sattler seconded the motion. The vote was: Mr. Weiss-yes, Mr. Marsh-yes, Mayor Pro Tem Peña-yes, Ms. Sattler-yes, Mr. Heath-no, Mayor Gonzales-yes. The motion carried.

9G. 2017-5811

Authorizing the City Manager to approve the purchase of playground equipment and installation of the same for the Stone Hill Park Project from We Build Fun, Inc in the amount of \$154,159.80 utilizing the Texas Association of School Boards (TASB) cooperative purchasing contract (BuyBoard).

Mr. Hemenes provided information and answered questions of the Council. Mr. Heath made a motion to approve the item as presented. Ms. Sattler seconded the motion. All voted in favor. The motion carried.

10. Discuss and consider action

10A. <u>2017-5819</u>

Discuss and consider action to award a construction contract for the Gilleland Creek Trail project to Boretex, LLC, the lowest responsible bidder of ten (10) bids received on April 20, 2017, in the amount of \$289,777.10 and authorizing the City Manager to execute same.

Ms. Giannini and Mr. Word provided information on the item. Mr. Marsh made a motion to approve the item as presented. Mr. Weiss seconded the motion. All voted in favor. The motion carried.

10B. RES-0411

Discuss and consider action to approve a resolution amending rules of order and procedure for City Council meetings. (Requested by City

Council)

Mr. Hyde provided information and discussed with Council. He stated that staff has recommended a start date of June 1, 2017. Mr. Weiss indicated concerns with adding an invocation. Ms. Sattler indicated to agree with Mr. Weiss. Mr. Heath stated that he thinks that it reflects the community and could be reversed if it becomes problematic. Mr. Weiss made a motion to approve the resolution with striking Section 11, removing the invocation and providing a June 1, 2017 effective date. Mr. Peña seconded the motion. The vote was: Mr. Weiss-yes; Mr. Marsh-no; Mayor Pro Tem Peña-yes; Ms. Sattler-yes; Mr. Heath-no; Mayor Gonzales-no. The motion failed. Mr. Heath made a motion to approve as presented with the June 1, 2017 effective date. Mr. Marsh-seconded the motion. The vote was: Mr. Weiss-no; Mr. Marsh-yes; Mayor Pro Tem Peña-no; Ms. Sattler-no; Mr. Heath-yes; Mayor Gonzales-yes. The motion

10C. RES-0416

Discuss and consider action to approve a resolution with the caption reading: RESOLUTION AMENDING RESOLUTION 1473-16-01-16-0289 MODIFYING THE RESOLUTION TO CANCEL THE PROHIBITION OF CONCEALED HANDGUNS AT MEETINGS GOVERNED BY THE TEXAS OPEN MEETINGS ACT. (Requested by Councilmember Doug Weiss)

Mr. Weiss made a motion to approve the resolution as presented. Mr. Heath seconded the motion. Mayor Gonzales indicated concerns for changing to allow concealed carry at Council meetings. Ms. Sattler indicated to agree with Mayor Gonzales. The vote was: Mr. Weiss-yes; Mr. Marsh-yes; Mayor Pro Tem Peña-yes; Ms. Sattler-no; Mr. Heath-yes; Mayor Gonzales-no. The motion carried.

10D. 2017-5840

Discuss and consider action regarding residential and commercial solid waste and recycling services.

Ms. Gillam provided information. She stated that staff would like to negotiate with the current residential provider. Council discussion followed. Staff was to return to Council with the current residential provider's proposal on June 27, 2017. The Council was in agreement to not to make changes to commercial solid waste at this time. Mr. Marsh made a motion to initiate negotiations as discussed and to not include commercial. Mr. Heath seconded the motion. All voted in favor. The motion carried.

10E. 2017-5847

Discuss and consider action to no longer require city council approval for the acquisition, modification or release of easements with a related cost not to exceed \$50,000, thereby allowing for administrative approval by the City Manager.

Mr. Wede provided information. He stated that these items are frequently included on Council agendas but seem to be more administrative in nature. Mr. Weiss stated that there also seems to sometimes be an issue with timeliness. He stated that he is in agreement, but that releases should still come to Council. Mr. Weiss made the motion to approve the item with the amendment to not include releases. Ms. Sattler seconded the motion. The vote was: Mr. Weiss-yes; Mr. Marsh-yes; Mayor Pro Tem Peña-yes; Ms. Sattler-yes; Mr. Heath-no; Mayor Gonzales-yes. The motion carried.

10F. 2017-5812

Discuss and consider action regarding future agenda items.

Mayor Gonzales requested a presentation at a worksession in June regarding the City's Emergency Management Program. Mr. Heath requested items 2E, 2F and 2G from tonight's worksession be placed at the top of the next worksession agenda. Mr. Hyde asked if they would like item 10B to be placed on an upcoming agenda. There were no requests to bring the item back.
