4. Public Comment

Anthony Nguyen, 19905 Tree Sap Way, thanked the Council for the Greenridge stoplight. He stated that he was at the meeting to speak regarding item 9E, the possible purchase of the Blackhawk golf course. He stated that he is not in favor of the city purchasing the golf course, that it should be purchased by a private entity. He asked if the city had reviewed the financials and only to consider purchasing if the cost is at or below market value. He stated that the city can control the development with zoning. He stated that the city has already subsidized a water park and he would hate to see the city make another bad decision and to subsidize another business.

Daniel Dower, 7707 Wolverine Street, stated that he is a teacher with the Pflugerville Independent School District and has 18 AVID students that are developing their skills and he is sharing their concerns with the proposed curfew ordinance. He read the list of student concerns to include that the ordinance is not fair to minors that haven't done anything wrong; that the ordinance limits the ability for teens to help out at home with some teens that are of driving age picking up younger siblings and items from the store; and that teens facing unnecessary curfew charges could affect their education.
