2A. <u>2017-6271</u> Discuss Pflugerville Animal Welfare Services fee schedules.

Ms. Gillam provided introductory information. Ms. McLendon provided an area animal shelter fee comparison. Council discussion followed regarding setting fees and cost recovery. Council requested to view a comparison of the costs and revenues prior to setting new fees.

Ms. McLendon provided information and asked if Council would like to provide a limit on number of pets allowed and discussed with Council. Mr. Weiss indicated that he would recommend strengthening the nuisance ordinance instead. Mr. Heath recommended putting a number in place to provide the ability for enforcement. Mayor Gonzales indicated to agree with Mr. Weiss. Mr. Marsh asked if this is currently a problem. Ms. McLendon stated that it is only a problem from time to time.

Ms. McLendon asked regarding livestock requirements. She provided information and indicated that the City does receive complaints regarding livestock. She stated that they are just seeking guidance from the Council if they would like to put some requirements in place. Mr. Heath recommended that she look at best practices and come back with a recommendation. Mr. Marsh stated that the other cities have some good examples. Mr. Weiss stated that he thinks that they can address noise and odor in the nuisance ordinance and should focus on animal welfare.

Ms. McLendon explained that we are the only City in the area that has no

requirements concerning exotic and dangerous animals and discussed possible ordinance provisions with the Council.

Ms. McLendon was to bring back further recommendations at an upcoming meeting.
