### **Regular Meeting**

### 1. Call to order

Mayor Victor Gonzales called the regular meeting to order at 7:01 p.m. Councilmembers Doug Weiss, Jeff Marsh, Omar Peña and Mike Heath were in attendance. Councilmember Starlet Sattler was absent. The resolution was approved on the consent agenda.

ORD-0372 Approving an ordinance on first reading with a caption reading AN ORDINANCE OF THE CITY OF PFLUGERVILLE TEXAS CLOSING, VACATING, ABANDONING AND CONVEYING A PORTION OF KELLY LANE IN THE CITY OF PFLUGERVILLE, TEXAS; AUTHORIZING THE CITY MANAGER TO EXECUTE A DEED WITHOUT WARRANTY; PROVIDING THAT THIS ORDINANCE SHALL BE CUMULATIVE; REPEALING ALL ORDINANCES TO THE EXTENT THEY ARE IN CONFLICT; PROVIDING FOR SEVERABILITY; AND DECLARING AN EFFECTIVE DATE.

Mayor Gonzales opened the item for consideration and Ms. Thompson read the caption of the ordinance under consideration. A revised ordinance was provided on the dais. Mr. Zech stated that he had provided minor changes to

the ordinance and that Section 3 now allows the City Manager to execute the deed and to hold in escrow. He stated that the effect of the ordinance is the same. Mr. Marsh made a motion to approve the ordinance on the first reading as revised. Mayor Gonzales seconded the motion. All voted in favor. The motion carried.

The vote was: Mr. Weiss-yes, Mr. Marsh-no, Mayor Pro Tem Peña-yes, Mr. Heath-no, Mayor Gonzales-yes. The motion carried.
