#### 1. Call to order

#### 2. Resolutions

**2A.** <u>RES-0470</u> Discuss and consider action to approve a resolution canvassing the votes of the November 7, 2017 General Election.

Mayor Gonzales read the results of the November 7, 2017 General Election. For City Council Place 2: Jeff Marsh received 1,367 votes and Adeline Bui received 1,315 votes. For City Council Place 4: George Lueck recieved 654 votes and Rudy Metayer received 2,013 votes. For City Council Place 6: Jim McDonald received 1,532 votes and Victor Johnson received 1,099 votes. Mayor Pro Tem Peña made a motion to approve the resolution canvassing the votes of the November 7, 2017 General Election. Ms. Sattler seconded the motion. All voted in favor. The motion carried. Mr. Marsh was elected to City Council Place 2; Mr. Metayer was elected to City Council Place 4 and Mr. McDonald was elected to City Council Place 6.

Ms. Sattler stepped down from the dais and Mr. Metayer and Mr. McDonald took their places on the dais.

Mr. Metayer made a motion to adjourn the meeting. Mr. McDonald seconded the motion. The meeting was adjourned at 6:09 p.m. A social reception followed the meeting and ended at 7:45 p.m.
