The City Council is scheduled to hold a Worksession starting at 6:00 p.m. Please see the Worksession Agenda for a list of items for discussion at the Worksession.

#### 1. Call to order

Mayor Victor Gonzales called the regular meeting to order at 7:07 p.m. Mayor Pro Tem Omar Peña and Councilmembers Jeff Marsh, Rudy Metayer, Mike Heath and Jim McDonald were in attendance. Councilmember Doug Weiss was absent. [2018-6798](#) Discuss and consider action to award a construction contract for the 2018 Community Development Block Grant (CDBG) Pavement Rehabilitation Project on Mill Creek Rd. and Green Meadows St. to Smith Contracting Company, the lowest responsible bidder of six (6) bids received on May 10, 2018, in the amount of \$545,038.00 and authorizing the City Manager to execute same.

Ms. Barron provided information on the item and answered questions of the Council. Ms. Giannini and Mr. Wood provided input. Mayor Pro Tem Peña moved to approve. Mr. McDonald seconded the motion. All voted in favor. The motion carried.

Council discussed a future agenda item to look at CIP roadway costs. Mr. Fletcher indicated that he plans to bring an item forward on June 12, 2018 to discuss Capital Improvement Projects. Mr. Heath stated that he would like an update on the absorption study. Mr. Fletcher stated that is planned for discussion in June. Mr. Heath stated that he would also like to discuss how that can relate to the corridor overlay. Mr. McDonald requested an item to discuss how the city can leverage strategic partnership agreements when annexing. Mr. Heath requested an item to discuss development transportation planning in the ETJ.

Executive Session Item: Consultation with legal counsel pursuant to Section 551.071 of the Texas Government Code for discussion regarding existing and future legal obligations relating to providing water and wastewater services, including legal issues related to water and wastewater Certificates of Convenience and Necessity (CCN) in the City's extraterritorial jurisdiction. 2.) Open Session Item: Discussion regarding water and wastewater services in the City's extraterritorial jurisdiction and existing Certificates of Convenience and Necessity (CCN).

There was discussion in open session on the item. Ms. Giannini provided information on the city's past plans to provide wastewater service in the ETJ and to annex in the future. She explained that with Senate Bill 6, annexation in Tier 2 cities, like the City of Pflugerville, requires petition of the individual landowner, petition of an area with less than 200 population or election of an area with 200 or more population. She explained that the city is currently evaluating current wastewater obligations in the ETJ, evaluating the cost of infrastructure to serve the Cottonwood Basin in the ETJ, and the sustainability of wastewater rates and impact fees in the Cottonwood Basin as well as the current and proposed CCN boundaries and implications to build out population projections. She explained that the city does not have current infrastructure on the ground in the Cottonwood Basin. Mr. Heath asked if they could have a vote of the entire Cottonwood Basin to see if they would like to be annexed. He asked how they can strategically define a rational annexation area that allows the city to provide wastewater and capture economic development without obtaining unnecessary obligations. Mr. Marsh asked what they would have to spend to fully service this area. Mr. Heath recommended annexing strategically. Mr. Marsh stated that he thinks the developability is years away and costs will be placed on the current payers. Ms. Giannini indicated that they would need to look at police and road costs in addition to water and wastewater. Discussion followed. Ms. Giannini noted that water CCN considerations would also be affected by Senate Bill 6.

Mr. Heath made a motion to adjourn. Mr. Marsh seconded the motion. All voted in favor. The meeting was adjourned at 9:13 p.m.
