1. Call to order

Mayor Pro Tem Omar Peña called the regular meeting to order at 7:04 p.m. Councilmembers Doug Weiss, Jeff Marsh, Rudy Metayer, Mike Heath and Jim McDonald were in attendance. Mayor Gonzales was absent. Mr. Heath thanked staff and PCDC for the study and stated that he looks forward to tying it back to the strategic retreat. Mr. Metayer congratulated the last unified class of Pflugerville ISD. Pflugerville High School had their 20th reunion and stated that it was a great time by all.

Ms. Holman invited the public to the July 4th Pfestival at the Pfield. She provided a video presentation.

Ms. Holman provided some comments about Parks and Recreation Month. Mayor Pro Tem Peña read and presented the proclamation to Parks and Recreation staff members in attendance.

Mary Albright, 602 Oak Ridge Drive, stated she does not like the restriping of Railroad. Mr. Fletcher stated the council cannot deliberate and referred her to speak with Ms. Giannini.

Ms. Meme Styles, 4536 Dennis Lane, was signed up to speak, but was not in attendance when called forward to speak.

Mr. Ernest Tomes, 16701 Heatherwilde, stated that he wanted public transportation for people who are blind. He stated this is important because transportation is huge for people like him who cannot drive. He stated that only so many times could he rely on friends. He stated that we have to have transportation for the blind and that CARTS stopped coming.

Mr. James Ware stated that there should also be public transportation. He stated that it is more than people like Mr. Tomes but also for people with economic reasons. He stated that we should not throw this by the wayside and look at this in terms of cost.

Ms. Gillam provided information on the item. She stated this postpones the rate increase 90 days so staff may take a look at what Atmos is doing. She stated staff will be coming back with a possible settlement. Ms. Gillam answered questions of the council. Mr. Weiss made a motion to approve the resolution. Mr. Marsh seconded the motion. All voted in favor. Motion carried.

		Justin LeBlanc, 905 Point Run Drive, spoke on the Athletic Complex and Randig Feasibility Study and its recommendations for four baseball fields, four new softball fields and converting the Little League Complex to a practice facility. He discussed the city's current plans at the 1849 park, providing for soccer and football. He provided information on the city's contract with the school district with responsibility of the city to maintain and provide improvement to the Pflugerville Little League fields. He asked the council to prioritize the Pflugerville Little League fields to make improvements.
