#### Regular Meeting

The City Council is scheduled to hold a Worksession starting at 6:00 p.m. Please see the Worksession Agenda for a list of items for discussion at the Worksession.

#### 1. Call to order

Mayor Victor Gonzales called the regular meeting to order at 7:00 p.m. Councilmembers Doug Weiss, Jeff Marsh, Rudy Metayer, Mike Heath and Jim McDonald were in attendance. Mayor Pro Tem Omar Peña was absent. **4. Presentation**

- 4A. [2018-7030](#)** Presentation of the Planner of the Year Award for the Central Texas Section of the American Planning Association Texas Chapter.

Mayor Gonzales announced that Ms. Barron is the recipient of this year's Groundbreaking Planning Award from the Central Texas Section of the American Planning Association Texas Chapter. He stated that the award is given in recognition of an individual who inspires and implements innovative planning techniques and comprehensive planning practices. He presented the award to Ms. Barron. Ms. Barron provided comments.

**5. Public Hearing**

- 5A. [ORD-0423](#)** Conduct the first of two public hearings on an ordinance with the caption reading: TAX LEVY ORDINANCE OF THE CITY OF PFLUGERVILLE, TEXAS FOR FISCAL YEAR 2019.

Mayor Gonzales opened the public hearing. He stated that the truth in taxation process requires the City to hold two public hearings on the tax increase proposed for fiscal year 2019 and this is the first of the two public hearings; with the second to be held on September 18, 2018 at 6:00 p.m. in the Council Chambers. He stated that these public hearings are required because the proposed tax rate for fiscal year 2019 of \$0.4976 is higher than the calculated effective rate of \$0.4870 and will raise more ad valorem tax revenue.

He stated that the proposed rate of \$0.4976 is equivalent to the FY19 calculated rollback rate and is a reduction from the FY18 adopted rate of \$0.5399. He stated that the proposed FY19 maintenance and operation rate is an effective increase of 8% over the FY18 maintenance and operation rate.

Anthony Nguyen, 19905 Tree Sap Way, stated that he is a Travis Central Appraisal District (TCAD) Board representative. He stated that the city increased appraisals 14% and explained that TCAD has to set values to the market values. He stated that people are upset that taxes are rising, but it is the taxing entities that set the rates. He stated that he has reviewed the budget and is happy to see a 4 cent reduction, but appraisals are up so they are paying an additional 8%. He stated that he would like to instead see a 2-3% inflation increase. He stated that people should carefully consider the ACC annexation. Mr. Heath clarified that TCAD increased the appraisals by 14%, not the city.

There were no additional requests to speak at the public hearing.

Mayor Gonzales announced that the second public hearing on the tax rate would take place on September 18, 2018 at 6:00 p.m. in the Council Chambers and the consideration of adoption of the tax rate would take place on September 25, 2018 at 7:00 p.m. in the Council Chambers.
