#### 1. Call to order

Mayor Victor Gonzales called the regular meeting to order at 7:00 p.m. The meeting was held by telephone/video conference. Mayor Pro Tem Omar Peña and Councilmembers Doug Weiss, Ceasar Ruiz, Rudy Metayer and Mike Heath were in attendance. Mr. Heath reminded everyone to take time to be thankful and count their blessings this Thanksgiving.

Barnes Survey No. 46, Abstract No. 67, in Travis County, Texas, of the Real Property Records of Travis County, generally located south of E. Pecan Street and west of SH 130; extending the boundaries of the City to include the land; and to be zoned Agriculture / Development Reserve (A); to be known as the Hagn Timmerman & RNDC 2020 Annexation; binding the land to all of the acts, ordinances, resolutions and regulations of the City; approving a service plan; providing for severability; and providing an effective date. Jesse Lister, Falcon Pointe resident; Jon and Dawn Grimes, Bohls Place residents; Lacy Wolff, Falcon Pointe resident; Karen Cunningham, Meadows of Blackhawk resident, Ron Cunningham, Meadows of Blackhawk resident; Lauren Brown, Verona resident; Logan Stehling, Commons at Rowe Lane resident; Blake Brown, Verona resident; and Gabriel Obiedo, Club at Wells Branch resident; provided written comments in support of holding an election for the Travis County ESD No. 2 overlay (Travis County ESD No. 17) for funding of Emergency Medical Services. Donald Wiederhold, Kuempel Tract Phase 2 resident, provided written comments with concerns regarding ordinance under item 7A. and the need for the city to have good cooperative plans in place to assist homeowners with planning for repairs. Bob Reichenbach, Saxony resident, provided written comments in opposition to the budget amendment under item 7B.

Mayor Gonzales announced that there were several requests to speak under public comment.

Jessica Foreman, League of Women Voters, thanked the City for providing direct and easy to understand language regarding the November 3, 2020 bond propositions. She stated that the information on the bond website was excellent and they wanted to publicly thank the City for providing this voter access.

Teri Lucas, Heatherwilde resident, provided comments in support of holding an election for the Travis County ESD No. 2 overlay (Travis County ESD No. 17) for funding of Emergency Medical Services.

Chris Wolff, Falcon Pointe resident, provided comments in support of holding an election for the Travis County ESD No. 2 overlay (Travis County ESD No. 17) for funding of Emergency Medical Services.

Lorrie Schutt, Villages of Hidden Lake resident, provided comments in support of holding an election for the Travis County ESD No. 2 overlay (Travis County ESD No. 17) for funding of Emergency Medical Services.

Mayor Gonzales opened and read the item to include the caption of the ordinance under consideration. All present voted in favor. Mayor Pro Tem Peña abstained and was absent and did not participate in the vote on the item. The motion carried. Mayor Pro Tem Peña returned to the meeting.

**13A.** <u>RES-0778</u> Discuss and consider action to approve a resolution with the caption: Resolution of the City of Pflugerville authorizing the City Manager to execute a Post-Annexation Provision of Services Agreement with Ebensee LLC, providing that upon annexation the City will provide standard City services to a tract of land totaling approximately 4.724 acres situated in the Joseph Wiehl Survey No. 8, Abstract No. 802, Travis County, Texas, within the City's extraterritorial jurisdiction. Mayor Gonzales opened the item for consideration. Ms. Barron provided information. Mr. Rogers made a motion to approve the resolution as presented. Mayor Gonzales seconded the motion. All voted in favor. The motion carried.

# **13B.** <u>RES-0785</u> Discuss and consider action to approve a resolution making additional appointments to the Charter Review Commission.

Mayor Gonzales opened the item and provided information. He stated that Mr. Weiss had appointed Darryl Houston and he has declined in order to retain his position on the Tax Reinvestment Zone No. One (TIRZ) Board and that Mr. Weiss has indicated that he will appoint Jim McDonald as his replacement. He stated that the City Council can appoint up to five additional members and indicated at the last meeting to allow the new Councilmembers to appoint two members each. He stated that Mr. Rogers has indicated that he would like to appoint Mark Gladney and Terry Newsom and Mr. Ruiz would like to appoint Kensing Marquez and Jeff Reeb. Mayor Gonzales stated that he would like to add Charlie Torres as an additional candidate. Mr. Rogers noted concern that Adeline Bui who was appointed on November 10, 2020 has a homestead in Austin. Mayor Gonzales stated that the City Secretary could look into that. Mr. Weiss made a motion to approve the resolution appointing the additional members as presented. Mr. Metayer seconded the motion. All voted in favor. The motion carried.

# **13C.** <u>RES-0789</u> Discuss and consider action to approve a resolution amending the Pflugerville Community Development Corporation (PCDC) bylaws to allow two City Councilmembers to serve on the PCDC Board of Directors and any other updates as needed.

Mayor Gonzales opened the item for consideration. Mr. Weiss indicated concern for Section 8.04 of the proposed bylaws. Mr. Fletcher provided information. Council discussion followed with input from Ms. Breland. Mr. Weiss stated concern that the section could cause delay. He stated that he thinks that Section 8.05 addresses any communications concerns. Amy Madison, Executive Director of the Pflugerville Community Development Corporation, provided information and discussed with Council. Mr. Rogers made a motion to not adopt the amended bylaws and to leave them as is. The motion died due to lack of a second. Mr. Metayer made a motion to approve the resolution and proposed bylaws without Section 8.04. Mr. Weiss seconded the motion. The vote was: Mr. Weiss-yes, Mr. Ruiz-yes, Mayor Pro Tem Peña-no, Mr. Metayer-yes, Mr. Heath-yes, Mr. Rogers-no, Mayor Gonzales-yes. The motion carried.
