Emily Draughon gave a presentation to receive public comment and consider an application to rezone an approximate 15-acre of land located at the southwest corner of the E. Pflugerville Pkwy and Weiss Ln intersection from Agriculture (A) to Urban Corridor Level 4 (CL-4); to be known as Tacara at Weiss Ranch Rezoning.

The applicants Paul Linehan and Erin Welch were also present.

Commissioner Seligman asked what this project entailed. Mr. Linehan replied that it would be primarily multifamily use with retail components.

Commissioner Hudson asked if any other zonings were considered aside from CL-4. Mr. Linehan replied that a PUD was considered however CL-4 allowed greater flexibility.

Commissioner Mitchell made a motion to close the public hearing. Commissioner Seligman seconded. All in favor.
