Discussion regarding transit service options for fiscal year 2023.

Mayor Gonzales opened item 2B. for discussion. Ms. Barron reviewed Capital Metro's pilot implementation including ridership and performance measures. Ms. Barron discussed the transit development plan goals and rideshare options. Julie Mazur with Capital Metro reviewed the FY23 proposed service options and the estimated budget.

Discussion regarding use of tobacco and nicotine products in City owned parks and trails system.

Mayor Gonzales opened the item for discussion. Mayor Pro Tem Weiss discussed tobacco and nicotine use in city owned parks and enforceability. Mayor Pro Tem Weiss stated he has heard concerns about litter at the lake and wanted to discuss eliminating some of the risk. Mr. McDonald commented on people smoking on the beach. Mayor Gonzales stated a no smoking sign may work. Discussion followed regarding enforcement and litter. Mr. Metayer asked if it is a widespread problem that needs to be looked into now. Discussion

followed regarding trash in parks. Mayor Gonzales stated that staff does not have a recommendation and if council decides it wants to come back with an ordinance council can bring the item forward.

Discussion regarding After Action Report (AAR) concerning the Pride Pfestival.

Mayor Gonzales opened items 2C. and 2D. at the same time. Mr. Mize provided information about the set up for both the Pride Pfestival and Juneteenth Celebration, cost, and turnout for each event. Mr. Metayer asked about revenues for the event and Mr. Mize provided information. Ms. Breland discussed an event policy forthcoming to hear what council expectations are for events. Discussion followed the city's role in events and location. Ms. Holiday asked if the same conversations are happening with the organizers. Mr. McDonald spoke about the planning from the organizers. Mr. Rogers stated having the policy after Deutschen Pfest would allow enough time to plan for next year's events. Discussion followed regarding event programming and food vendors.
