Approving a Professional Services Agreement with Halff Associates, Inc. in the amount Not to Exceed (NTE) \$200,000.00 for professional services associated with Traffic Signal Management projects and implementation of the Pflugerville Signal System Assessment & Improvement Plan and authorizing the City Manager to execute the same.

The professional services agreement being considered provides for Traffic Signal services and Traffic Data collection through the City, and On-Call services for Non-Project specific Traffic Engineering. The general work scope includes Intersection Analysis, Traffic Data Collection, Traffic Signal Warrant Analysis, Intersection Improvements, and Design, Bidding and Construction Administration wherever such services are warranted. These services are split in two main tasks: Traffic Signals Management and Traffic Data Collection and Analysis. Those are split into two forms of tasks: On-Call services and Planned services.

The initial projects and locations identified by the City as planned services include the intersections listed below:

- Pleasanton Parkway at Weiss Lane
- Olympic Drive at Dessau Road
- Olympic Drive at Heatherwilde Blvd
- Schultz Lane at A.W. Grimes Blvd.
- Village at Wells Branch

### **Prior City Council Action**

City Council approved the selection of Halff Associates as one of the three selected firms to assist the City with the Traffic Signal Management projects and implementation of the Pflugerville Signal System Assessment & Improvement Plan at the September 28, 2021 meeting.
