Portions of the Falcon Pointe Subdivision will be affected due to construction activities related to the installation of HA5 as a pavement preservation application and part of the Pavement Maintenance Program.

The City is amending Chapter 71 of our Code of Ordinances relating to parking on city streets by adding temporary no parking zones along portions of the Falcon Pointe Subdivision for construction activities related to the installation of HA5 as a pavement preservation application. The construction contract for this project is being recommended for approval at this meeting, May 24, 2022 as a separate item.
