Approving an ordinance on second reading with the caption reading: An Ordinance of the City of Pflugerville, Texas, Adopting the second amendment the Fiscal Year 2021 Budget for the City of Pflugerville, Texas; and providing an effective date.

The City's Finance Policy requires each department to manage expenditures within personnel, operating, and capital outlay budgets. A year-end process to balance across all departments is required to maintain compliance with Finance Policy. The budget amendment balances department operating expenditures and does not request additional appropriations.

Total FY21 Expenditures by operating fund amended budget and year-end actual:

General Fund: \$48,209,876 budget, \$44,830,441 actual

Water/Wastewater Utility Fund: \$38,069,782 budget, \$36,207,858 actual.
