Discuss and consider potential action relating to emergency medical services and potential contract.

This item has been included on the agenda for review and action regarding the selection of an Advanced Life Support (ALS) Emergency Medical Services provider. The City currently contracts with Allegiance Mobile Health to provide this ambulance service within the City limits. The contract with Allegiance Mobile Health will expire on June 30, 2024 and a new contract must be approved.

This item provides direction to the City Manager and the City Attorney, on behalf of the City, to finalize negotiations between the City and the selected EMS service provider to provide Advanced Life Support (ALS) EMS service in the City of Pflugerville.

This item is supported by the Safety pillar of the Strategic Plan.

### Prior City Council Action

City Council approved the Contract for Emergency and Non-Emergency Ground Ambulance Services for the City of Pflugerville with Acadian Ambulance Services of Texas - November 11, 2021. City Council approved termination of the Contract for Emergency and Non-emergency Ground Ambulance Services for the City of Pflugerville, Texas with Acadian Ambulance on March 8, 2022. City Council approved selection of Travis County ESD2 as the public provider of EMS and authorized the City Manager to enter negotiations regarding an agreement on May 10, 2022. City Council approved direction to staff to cease negotiations but seek a joint meeting with the City Council and Travis County ESD2 Board of Commissioners and begin negotiations with Allegiance Mobile Health on May 24, 2022.

City Council approved the Contract for Emergency and Non-Emergency Ground Ambulance Services for the City of Pflugerville with Allegiance Mobile Health - June 14, 2022. This contract will expire on June 30, 2024.

City Council authorized City Staff to negotiate contract terms with Allegiance Mobile Health and ESD2 for ALS EMS service on April 9, 2024.
