Approving an ordinance on second reading with the caption reading: AN ORDINANCE OF THE CITY OF PFLUGERVILLE, TEXAS, AMENDING THE CITY OF PFLUGERVILLE, TEXAS CODE OF ORDINANCES, BY AMENDING TITLE VII (TITLED TRAFFIC CODE), CHAPTER 72 (TITLED TRAFFIC SCHEDULES), SCHEDULE III (TITLED STOP SIGNS ON PUBLIC STREETS) BY ESTABLISHING ADDITIONAL STOP SIGN LOCATIONS IN STONE HILL TOWN CENTER; PROVIDING FOR A VIOLATION OF CHAPTER 72 AS A CLASS C MISDEMEANOR AND A FINE IN AN AMOUNT NOT TO EXCEED \$200.00; PROVIDING THAT THIS ORDINANCE SHALL BE CUMULATIVE; REPEALING ALL ORDINANCES TO THE EXTENT THEY ARE IN CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE. The City is amending Chapter 72 of our Code of Ordinances specifically relating to stop signs on public streets by adjusting the stop sign intersection at the following locations:

Stone Hill Town Center

- Add various existing stop-controlled public street approaches to the existing code of ordinances list.
- Amend various existing approaches in the code of ordinance verbiage to allow for technical corrections.

Status

The attached exhibits illustrate existing conditions, differentiating the existing signs that are being added and the signs that are being amended.

With adoption of this ordinance, the stop signs will be adjusted and updated in the list of other signs in the City's Code of Ordinances.

This ordinance has been approved by the City Attorney as to form.

This ordinance was approved on first reading on April 10, 2018.

Prior City Council Action

Chapter 72 regarding stop intersections on city streets was last amended by the City Council on February 27, 2018.
