Conduct a second public hearing and consider approval by resolution of the Community Development Block Grant (CDBG) program proposed 2018 Action Plan.

The CDBG program provides annual grants on a formula basis to entitled communities to develop viable urban communities by providing decent housing and a suitable living environment, and by expanding economic opportunities, principally for low- and moderate-income persons. The City of Pflugerville became an entitlement community in 2013 and developed the first 5-year Consolidated Plan and Annual Action Plan at that time. The Consolidated Plan serves as the application to the United States Department of Housing and Urban Development (HUD) for CDBG funding. The Consolidated Plan is designed to aid local jurisdictions in assessing their housing and community development needs and priorities. The priorities established by the Consolidated Plan are carried out through actions and activities each year as established in the Annual Action Plan.

The proposed 2018 Action Plan is attached to this agenda item and is available for public viewing Friday, June 8, 2018 through Tuesday, July 10, 2018 at the following link: www.pflugervilletx.gov/cdbg or at the Pflugerville Public Library and the Travis County Community Center.

The allocated funding available for actions and activities for the 2018 Program Year is \$265,024. This is an annual allocation and the estimated amount the City may anticipate receiving annually over the next five years. The projects presented reflect the needs identified by the CDBG Amended Consolidated Plan adopted by City Council in April of 2016 which emphasizes the need to focus projects on parks, infrastructure (sidewalks, trails, streetlights, roadways) and public service including senior projects and youth programs.

The total allocation for the 2018 Program Year is estimated at \$265,024. The proposed projects

include:

Youth Scholarship Program (\$20,000)

El Malino final design and construction of roadway improvements (\$140,024)

Bellemeade roadway design (\$100,000)

Alternate Project - Bellemeade construction

Administration Costs (\$5,000)
