There is a 20% funding match for this grant from the City which will be from salary and fringe benefits of the Victim Services Manager who will be overseeing the program. Approval is also requested to authorize the City Manager to sign all necessary documents upon final approval of the City Attorney. Please find the attached staff memo and resolution.

This grant would assist the department with establishing dedicated staff that will focues on victim related services for our citizens.
