Authorizing the City Manager to approve the purchase agreement with Alfa Laval, Inc. in the amount of \$1,245,000.00 for the Automatic Backwash Disk Filter Equipment for Phase 1 of the Wastewater Treatment Plant (WWTP) expansion project.

City staff is requesting approval for a purchase agreement with Alfa Laval, Inc. in the amount of \$1,245,000.00 for the Automatic Backwash Disk Filter Equipment for Phase 1 of the Wastewater Treatment Plant (WWTP) expansion project.

On October 23, 2018, Council approved a resolution authorizing the use of the competitive sealed proposal procurement method for the Central Wastewater Treatment Plant Expansion project, including the preselection of vendors for major treatment process equipment. As explained during a presentation by City staff at the October 23<sup>rd</sup> City Council meeting, preselecting equipment vendors prior to completing the design of the project will allow the City's engineering design consultant to finalize the design around a single process equipment supplier. This will avoid the need to issue a construction plan set with alternate designs for multiple vendors, which could cause confusion during the construction bidding process and potentially lead to higher bid prices, but will still allow the City to take advantage of the competitive bidding process for procurement of the equipment.

On November 28, 2018, City staff received competitive sealed proposals from vendors interested in providing automatic backwash disk filter equipment for Phase 1 of the WWTP expansion project. After a selection committee that included City staff from the Public Works and CIP Engineering departments reviewed and scored the proposals, the proposal provided by Alfa Laval, Inc. was selected as the best value for the City. The best value proposal included equipment for Phase 1 of the project at a total cost of \$1,245,000.00. Based on City staff recommendation, the selection of Alfa Laval as the best value proposal was approved by City Council at the January 22, 2019, meeting.

After negotiations with the product vendor the purchase agreement in the amount of \$1,245,000.00

was finalized and has been brought forward for City Council consideration. The equipment purchase agreement executed by the City will be reassigned to the general contractor for the construction of Phase 1 of the WWTP expansion project once selected this summer. Once the purchase agreement is reassigned, the contractor will assume all responsibility, including payment for the equipment, under the terms of the equipment purchase agreement.

### **Prior City Council Action**

City Council approved the selection of Alfa Laval, Inc. for the Automatic Backwash Disk Filter Equipment for Phase 1 of the Wastewater Treatment Plant (WWTP) expansion project on January 22, 2019.
