The PCDC Board met on August 21, 2019 and unanimously approved the transfer of the 9.8470 acres remaining portion of a 63.72 acre tract of land situated in the John C. Bray Survey No. 10, Abstract No. 73, Travis County, Texas.

The PCDC Attorney and City Attorney have reviewed the Warranty Deed.

The property is contiguous to other city property in the vicinity that enables the development of trails along greenways connecting various neighborhoods located west of Weiss Lane and south of Cele Road. Upon this transaction, the developer of Sorento will be extending a 10-foot wide trail segment across this parcel.
